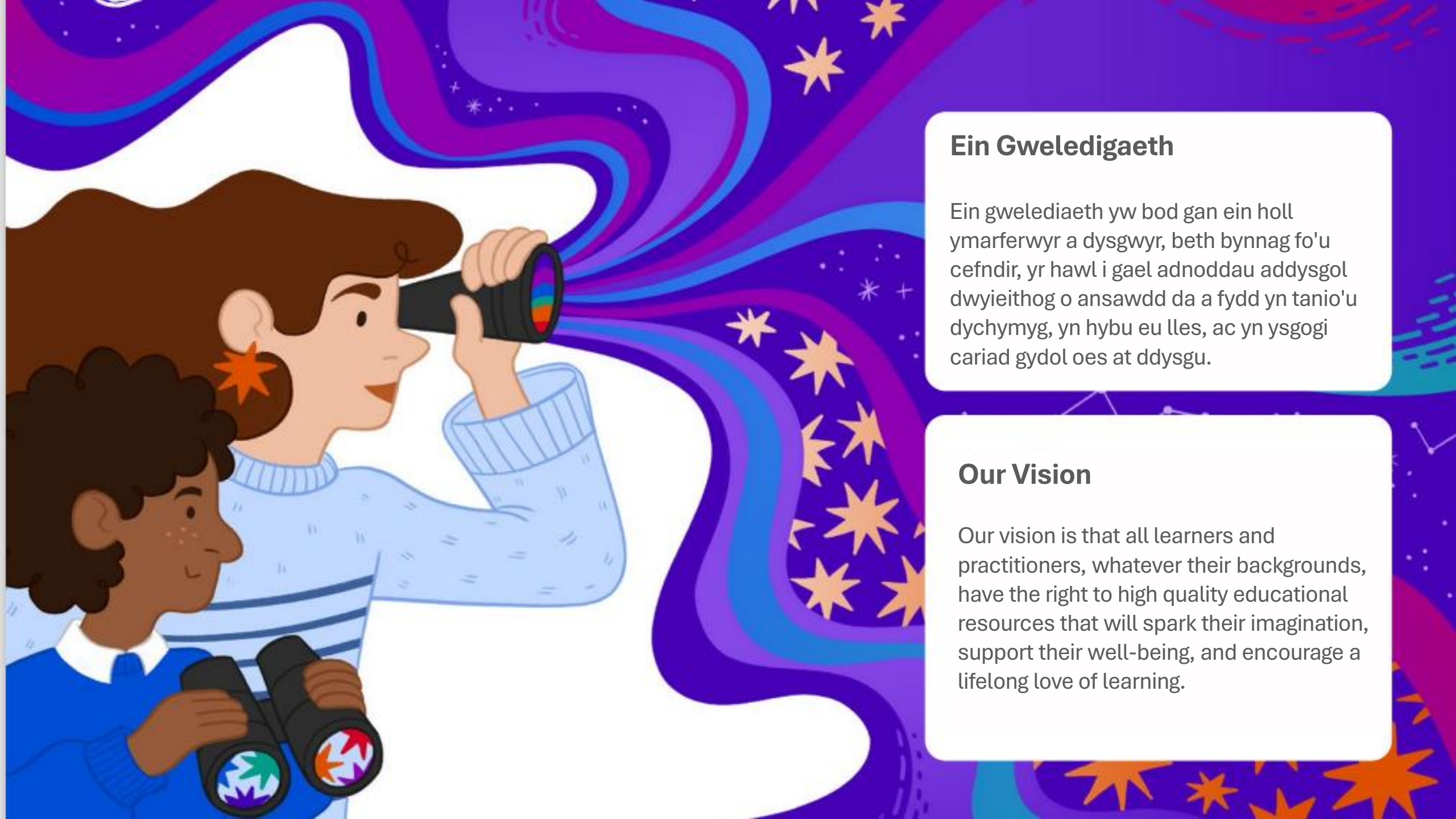

Aims

- The contract term will be 12 months, with the option to extend for up to a further 12 months, subject to evaluation.
- Magazine editions: published no later than 1/09/26, 31/12/26 and 31/03/27.
- £60,000 (inclusive of VAT)
- Primarily for GCSE learners age 14-16.

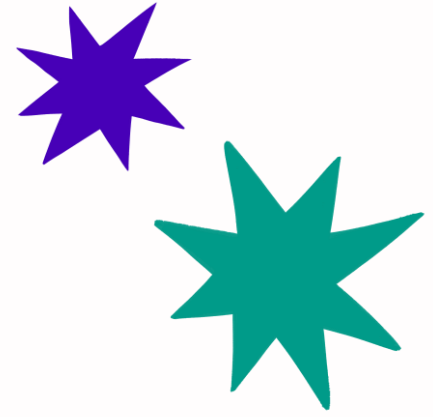

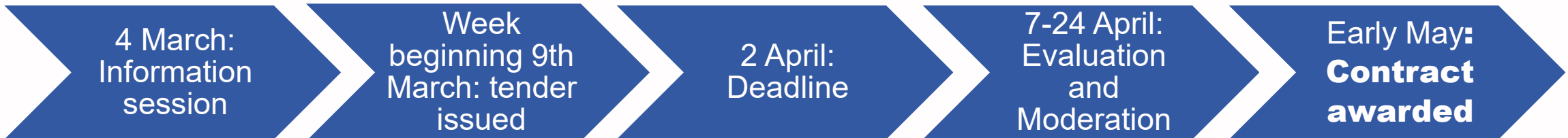
